Moved by Councilmember Hack, seconded by Councilmember Horne, and carried unanimously to approve the introduction and first reading of an ordinance, entitled:

AN ORDINANCE OF THE CITY OF LAGUNA WOODS, CALIFORNIA, AMENDING PORTIONS OF CHAPTER 13.20 OF THE LAGUNA WOODS MUNICIPAL CODE PERTAINING TO SIGN REGULATIONS

## 7.2 Disaster Recovery Initiative

City Manager Macon summarized the agenda report.

Mayor Conners opened the public hearing.

Kathryn Freshley, resident, suggested making copies of the Disaster Recovery Initiative projects available to various boards within Laguna Woods Village.

Councilmembers and staff discussed the suggestion made by Ms. Freshley.

Councilmembers discussed the item and staff answered related questions.

With no other requests to speak, the public hearing was closed.

Moved by Councilmember Moore, seconded by Councilmember Horne, and carried unanimously to approve a resolution entitled:

A RESOLUTION OF THE CITY OF LAGUNA WOODS, CALIFORNIA, TAKING ACTIONS RELATED TO THE COMPLETION OF THE 2008 DISASTER RECOVERY INITIATIVE GRANT

## VIII. CITY COUNCIL BUSINESS

8.1 Establishment of the City's Position on the Storage of Spent Nuclear Fuel at the San Onofre Nuclear Generating Station (agendized by Councilmember Horne)

Mayor Conners summarized the agenda report.

The following individuals spoke in favor of the City Council taking the recommended action:

Councilmembers discussed the item and staff answered related questions.

Councilmembers discussed modifying parts of the recommended action in order to gain consensus amongst the City Council. The City Council decided to vote separately on each suggested modification to the resolution.

City Attorney Cosgrove stated that the "first whereas" would be amended to state, "the City of Laguna Woods is located approximately 20 miles from the San Onofre Nuclear Generating Station in a densely populated area of Orange County, California."

Moved by Councilmember Horne, seconded by Mayor Pro Tem Hatch, and carried with Councilmember Hack abstaining, to amend the "first whereas" as read by the City Attorney.

Councilmember Hack noted that he would be abstaining due to his opposition to the resolution.

City Manager Macon stated that the "fourth whereas" would be amended to state, "the City of Laguna Woods is located within the 50-mile ingestion pathway mandated by the Nuclear Regulatory Commission yet is not included in San Onofre Nuclear Generating Station nuclear release incident evacuation planning and practice drills."

Moved by Councilmember Moore, seconded by Councilmember Horne, and carried with Councilmember Hack abstaining, to amend the "fourth whereas" as read by the City Manager.

City Attorney Cosgrove stated that the "eighth whereas" would be amended to state, "notwithstanding assurances of safety, spent nuclear fuel leaks have occurred at nuclear facilities, which create concern that accidental leaks of spent nuclear fuel are possible with resulting harm and imperilment to public safety."

Moved by Councilmember Moore, seconded by Councilmember Horne, and carried with Councilmember Hack abstaining, to amend the "eighth whereas" as read by the City Attorney.

City Manager Macon stated that "section 1" would be amended to state, "The City of Laguna Woods supports the identification of a long-term storage site located away from populated areas as soon as possible and with all reasonable dispatch and that while spent nuclear fuel is stored at the San Onofre Nuclear Generating Station, it must be stored in a manner that is as safe as possible, including but not limited to, that it is inspectable, transportable, and includes continuous real-time monitoring information made available to the public."

Moved by Mayor Pro Tem Hatch seconded by Councilmember Horne, and carried with Councilmember Hack abstaining, to amend "section 1" as read by the City Manager.

City Attorney Cosgrove stated that "section 2" would be amended to state, "The City of Laguna Woods asserts that the proper storage and disposition of spent nuclear fuel must be a consideration in the decommissioning process and that the decommissioning plan must not be considered complete until those issues are resolved."

Moved by Councilmember Moore seconded by Councilmember Horne, and carried with Councilmember Hack abstaining, to amend "section 2" as read by the City Attorney.

Moved by Councilmember Horne, seconded by Councilmember Moore, and carried with Councilmember Hack abstaining, to approve a resolution, as amended, entitled:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAGUNA WOODS, CALIFORNIA, ESTABLISHING THE CITY'S POSITION ON THE STORAGE OF SPENT NUCLEAR FUEL AT THE SAN ONOFRE NUCLEAR GENERATING STATION

Mayor Conners called for a brief recess.
