# A. No Right Turn on Red Light Alternatives

Assistant City Manager Reilly discussed the possible use of red light arrows as an alternative to no right turn on red light restrictions. The Committee voted 3 to 2 to support testing red light arrows at the Towne Center intersection and Laguna Woods Village Gate 7 intersection, with its first priority as Gate 7.

# B. Rights of the Individual vs. Rights of the Community

The Committee reviewed their past discussions and made the following recommendations to the City Council:

- 1. Modify the City's smoking regulations to prohibit smoking on or in unenclosed patios and balconies in multifamily buildings. Direct staff to prepare such an ordinance for introduction and first reading at the January 19, 2011 City Council meeting.
- 2. Increase the City's fire safety/prevention education program efforts through use of the City's newsletter, website and cable channel; consider funding for a citywide fire safety event as a part of the midyear budget review process.
- 3. Develop and make available educational, referral and contact materials about elder abuse and hoarding. Disseminate such information using the City's newsletter and website.
- 4. Defer action on adoption of interior property maintenance regulations until the Village homeowners associations finalize and adopt clutter policies and procedures.
- 5. Request a written clarification from the Orange County Fire Authority regarding their response protocols to internal property maintenance complaints about potential fire danger.

Member Leuck requested that the Public Safety Committee discuss illegal use of golf carts on the El Toro Road sidewalk. City manager Keane noted that the City Council has already heard a resident complaint on this matter

and has not directed staff to investigate further. Staff has safety concerns regarding the installation of bollards in the sidewalk, but is adding additional signage.

In response to comments by Member Margolis regarding the perceived poor timing of traffic signals on El Toro Road, City Manager Keane stated that the pause between lights is a State law requirement, but that there could be problems. Individuals should notify Doug Reilly and he will check to assure that timing is correct.

Member Rosenblatt commented that the individuals who ignore existing traffic prohibitions will also ignore new prohibitions and signs.
