COMMITTEE BUSINESS

A. Residential Smoke Alarm Program

Nannette Edwards, Program Coordinator with the Orange County Fire Authority (OCFA), discussed OCFA's Smoke Alarm Program, which includes the installation of free residential smoke alarms and fire safety education. The City and OCFA are collaborating on a pilot program in Laguna Woods Village with the goal of expanding it citywide.

Committee discussion included possible alternatives to the use of drills for installation and the validity of fire statistics provided by OCFA.

B. Santa Maria Golf Cart Path

The Committee received a presentation from City Manager Keane and voted to recommend approval of the Santa Maria Golf Cart Path to the City Council by a 9-1 vote with Member Malone dissenting.
