I. CALL TO ORDER

Chair Oakes called the meeting to order at 9:33 a.m.

II. ROLL CALL

III. COMMITTEE BUSINESS

A. Fiscal Year 2014-15 Budget Preparation

Community Services Manager Foley reviewed the agenda report.

Administrative Coordinator Trippy discussed the City's senior mobility taxi voucher program.

Committee members provided the following input regarding the Fiscal Year 2014-15 budget:

- General travel taxi voucher books should continue to be sold in \$100 (sold at \$50) and \$50 (sold at \$25) denominations.
- The City's taxi voucher brochure should have a statement that reads "No cash refunds for unused or expired taxi vouchers after June 30th

- of each year." Residents should not be able to trade in expired taxi vouchers after July 31 annually. This information should be provided to residents when they purchase taxi vouchers.
- Special destination vouchers should not be sold to the Irvine Spectrum.
- The City's taxi voucher brochure should be updated to clearly identify any limitations on the number of non-emergency medical trips and the number of passengers able to ride along.
- The City should reinstate its practice of providing local hospitals with general travel taxi voucher books for residents who have been taken to the emergency room by ambulance and do not have a means of transportation home when they are released by the hospital.
- The City's agreement with California Yellow Cab should be extended for another fiscal year with service levels/fares adjusted as necessary to stay within the funding allocation and budget for the fiscal year.
- Due to the presence of services provided by the City and Age Well Senior Services, transportation should no longer be an eligible service for the Community Services Grant Program.
- Due to the significant local need for social services, a majority of the committee members felt that social services programs should be the highest and only eligible service.
- There is interest in replacing or adding new street banner designs.
- Sunday movie matinees should continue.
- The City should explore sponsoring a program with OC Human Relations to promote and celebrate the City's cultural diversity. Ideas include a one book/one community event, movie discussion program, or cultural diversity activity.
- The City should host an annual E-Reader Workshop and other events to inform and educate residents and library patrons on the latest technologies being utilized by OC Public Libraries.
- The City should explore opportunities that would allow the sale of books at City Hall in support of City/OC Public Libraries programs. It is difficult to schedule author events without books being sold.
- Committee members noted that input was provided at the February 26, 2014 meeting regarding the City's website.
- The City should keep its video and audio equipment compatible with future upgrades by the Golden Rain Foundation's Broadband Services

and continue to use Channel 31 to inform residents and promote City events and activities.

- The City map/guide should be updated to highlight shopping centers, golf cart paths, hiking trails, churches, hospital, medical facilities, and urgent care facilities in the City. The map should also include points of interest in surrounding areas, including museums, performing arts, and major cultural events like the Laguna Beach Art Festival.
- The City should implement a recognition program for city volunteers who volunteer at City Hall and on advisory committees.

Member Unatin remarked that many people are unaware that the City stopped selling John Wayne Airport taxi vouchers in 2012.

Member Singer expressed an interest in the City's budget process.

V. PUBLIC COMMENTS

Robert Sherinian stated that the apartment community off of Moulton Parkway in Laguna Hills should be included in diversity programs.

VI. ADJOURN

Briefly describe the program/service funded by the grant from the City of Laguna Woods:

Braille Institute's Laguna Woods Community Outreach Program helps residents with low to no vision learn adaptive skills that help them maintain independence, develop self-confidence, and improve their quality of life. Thanks to the generosity of donors like the City of Laguna Woods, all services are provided completely free of charge to residents in the comfort and familiarity of their home or community.

How many residents or workers in the City of Laguna Woods were served by the grant-funded program/service this quarter?

During the 1st quarter of 2014, 185 residents were served through classes, trainings, in-home visits and presentations.

Briefly describe the grant-funded tasks performed during this quarter:

From January 1 thru March 31, 2014: 9 Low Vision Consultations were conducted. Our newly-hired Low Vision Specialist goes to Laguna Woods twice a month. 5 Orientation and Mobility trainings were held. 4 Independent Living Skills classes were held: Understanding Low Vision with 12 attending; Staying Connected with 11 attending; Business of Living with 7 attending; and Gizmos and Gadgets with 9 attending. 3 monthly Peer Counseling Support Groups were held with 25 residents attending each. A Focus Group was held for the Low Vision Club at Laguna Woods Club House to discuss programming and the needs of people with low to no vision as well as an overview of services provided by Braille Institute – 24 visually-impaired people and 7 caregivers attended. 2 Day of Discovery tours were held on campus on January 17 and March 21

for 16 Laguna Woods residents and were offered cooking classes, technology presentation, and library services.

CITY OF LAGUNA WOODS QUARTERLY REPORTING FORM

Briefly describe your grant funded program/service goals and how effective you have been in meeting those goals during this quarter.

The goal of Braille Institute's Laguna Woods Community Outreach Program is to help visually impaired residents learn the skills necessary to adapt to vision loss so that they may maintain their independence and quality of life. This is achieved through low vision rehabilitation consultations, independent living skills training, individual and group support; and informative lectures and classes. Our objective in 2014 is to serve 675 residents. Current numbers served represent 27% of our established goal and we expect to reach our objective. Furthermore, we take advantage of every opportunity to increase visibility and community engagement – our Educational Program Manager was interviewed by local Laguna Woods TV channel Media 55 and we participated in the Senior Summit in Laguna Woods with 500 in attendance. Activities like these are crucial to expanding awareness of the services we offer to the visually-impaired.

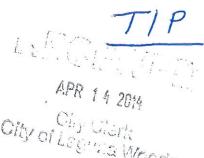

Most of the assistance during the reporting period was in the form of emergency food. Clients received a week's worth of free food including fresh produce and bakery items as well as, non-perishable canned items. Clients can visit the South County Outreach Food Pantry once a month for as long as they need help. Due to a recent relocation that shut down operations for a significant portion of January and hiring of new staff — Director of Operations, Director of Marketing, and Contract & Grants Manager — the numbers of total individuals served is much lower than average for the quarter. South County Outreach understands its year-long requirements and remains on track to meet all 2014 goals.

Additionally, vital help in the form of rental and utility assistance was provided to needy residents of South Orange County in order to avoid eviction and/or shut-off of services. Others received free computer skills training at our Computer Learning Lab enabling them to improve their job skills and the ability to find work.

Included, please find a **Grant Expenditure Report** reflecting agency expenses of \$5,000 for the quarter. Funds from the City of Laguna Woods are used to offset the quarterly Facilities expense of building rent (\$24,177.51). Attached please find copies of rent checks as expense documentation. Please note that monthly rent is 8,059.17 for a quarterly total of \$24,177.51. This is reflected on the March 2014 check and will be the same on-going, and lower amounts in January/February are due to credit from deposits made prior to the official move. CITY OF LAGUNA WOODS Quarterly Report

Reporting Period: January 1, 2014 - March 30, 2014

1. Briefly describe the program/service funded by the grant from the City of Laguna Woods:

The funds awarded by the city of Laguna Woods allows the Aging with Vision Loss Program to provide direct services to older adults fifty-five years of age and older who are experiencing a visual impairment. The home-based services include independent living skills (ILS) training, peer support, introduction to assistive technology, adaptive writing skills, adaptive diabetic equipment (ADE) training, and coordination of other vision loss related services. AVL Program services are provided free of charge to residents of Laguna Woods and are tailored to meet each individual's needs.

2. How many residents in the City of Laguna Woods were served by the grant-funded program/service this quarter?

This quarter the AVL program served 2 new individuals, which set ten goals and met seven of their self-directed goals. Also, there were thirty-two ongoing individuals who continued to receive services. Overall, these individuals received 69 instances of service from the Aging with Vision Loss Program.

3. Briefly describe the grant-funded tasks performed during this quarter.

Below is an example of the services provided to Laguna Woods residents this quarter, which speak to the grant-funded tasks set forth in the grant application.



CITY OF LAGUNA WOODS Ouarterly Report

The ILS Counselor responsible for the Orange County service area conducted an in-home appointment with a new consumer in the city of Laguna Woods. The consumer is an 86-year-old female with a history of wet macular degeneration and was referred to the Aging With Vision Loss Program by the Braille Institute. Written communication, access to personal information, transportation, access to house-hold appliances and telephone access were identified as areas where the consumer is encountering some difficulty. A signature guide was issued to the consumer. The ILS Counselor provided a hands-on demonstration of the Wilson digital recorder, as the consumer requires an alternative means for capturing and reviewing important personal information. Information and referral was provided for OCTA Access transportation services, as the consumer wishes to travel independently. The consumer identified her microwave, TV remote-control and oven as household appliances that she has trouble operating. Tactile markings were placed on these appliances based upon the consumer's specific preference. The consumer also reported that she is beginning to struggle when using the telephone. The ILS Counselor provided information and referral for the California Telephone Access program, explaining eligibility criteria, the application process as well as the various phones and features available. The ILS Counselor advised the consumer that a portion of the CTAP application must be completed by the consumer's physician prior to submission. The consumer also expressed interest in purchasing a hand-held video magnifier; going on to say that she simply cannot afford to purchase a new unit. The ILS Counselor agreed to contact local CCTV venders to enquire about any second-hand hand-held video magnifiers. The ILS Counselor will be following up with the consumer regarding this matter as well as the consumer's status regarding OCTA Access and the California Telephone Access Program.

95% of seniors with both vision loss and diabetes will show improved management of their diabetes due to learning about adaptive diabetic equipment and strategies. Result: In the 1st quarter there were no program participants who were assisted with both vision loss and diabetes.

Recommended Action

Provide input to staff regarding the City's Fiscal Year 2014-15 budget.

Background

Preparation of the City's Fiscal Year 2014-15 (July 1, 2014 through June 30, 2015) budget is now underway. The budget outlines a financial plan and scope of work for the City to undertake during the specified period of time.

Discussion

This year – to further the City's commitment to transparency and public outreach – staff has expanded the budget process to include additional opportunities for input from the City's standing advisory committees and general public.

At today's meeting, staff is requesting input on matters regarding the City's Fiscal Year 2014-15 budget as they relate to community services, including matters on which the City Council has provided preliminary direction. This is an opportunity to propose new programs, modifications to existing programs, and other suggestions, thoughts, or ideas for consideration in the City's upcoming budget.

Community services-related topics include:

- Transportation
- Health and social services
- Community beautification
- Recreation

- Cultural programs
- Community communications
- Public relations

The City Council's policy establishing the Community Services Committee states that the "committee shall strive to promote the [City] as a community that embraces diversity and supports programs and services that benefit all of its residents."

Preliminary Direction

The City Council provided the following direction on community services-related topics at the meeting on April 30, 2014. This direction is not final; staff will use the direction to prepare a draft General Fund budget for future consideration.

Priority Focus Areas

The City Council unanimously concurred with the following priority focus areas identified for the Fiscal Year 2014-15 budget:

A city that is ...

- Healthy and safe
- High in quality of life
- Environmentally conscious
- Economically prosperous
- Fiscally responsible
- Professionally and efficiently served

Senior Mobility Taxi Voucher Program

The City Council unanimously directed staff to include funding to support the taxi voucher program, with no increases in costs per trip, in the draft Fiscal Year 2014-15 budget. The City Council also unanimously directed staff to include funding to explore partnerships and program modifications to focus on the areas of greatest need for the taxi voucher program in the draft Fiscal Year 2014-15 budget.

Community Services Grant Program

The City Council unanimously directed staff to include \$150,000 for competitive community services grants in the draft Fiscal Year 2014-15 budget and expressed a desire to have a more in-depth discussion of the Community Services Grant Program and associated policies. The City Council did not take action to allocate a portion of the \$150,000 for specific grantees. The City Council will continue its discussion of this program at the meeting on May 28, 2014 at 2 p.m.

Santa Maria Passive Park/Trailhead

The City Council unanimously directed staff to remove the Santa Maria Passive Park/Trailhead Project from the City's capital improvement project list.

General Plan Updates

The City Council unanimously directed staff to include funding for a comprehensive update of the General Plan Conservation Element and general plan resident and business survey in the draft Fiscal Year 2014-15 budget. This is first part of what is envisioned as a two fiscal year process to complete a comprehensive update of the entire General Plan, which would involve community services issues.

Fiscal Impact

The City Council will consider adoption of the Fiscal Year 2014-15 budget in June. Upcoming public budget meetings are scheduled for the City Council meetings on May 28, 2014, June 18, 2014, and June 25, 2014.

Conclusion

Community Services Committee input on this item will help ensure that the City's Fiscal Year 2014-15 budget is responsive to community needs.
