A. 2013 Community Services Grant Recommendations

Community Services Manager, Patrick Foley introduced representatives from various non-profit organizations in attendance and invited them to make presentations to the Committee about their 2013 applications for grant programs and/or services. After review and discussion, the Committee recommended to the City Council grant awards to the

following agencies: Braille Institute \$20,000, South County Outreach \$20,000, Trauma Intervention Program \$5,000, Dayle McIntosh Center \$10,000, Laura's House \$2,500, Laguna Canyon Foundation \$2,500 (Member Rhodes recused herself), the Foundation of Laguna Woods Village \$15,000 (Member Levine recused herself), and a total of \$75,000 to Age Well Senior Services for Adult Day Services \$22,500, Transportation \$22,500, and Florence Sylvester Memorial Senior Center \$30,000.

B. Status of City Hall/Library Accessibility Improvements Project

The Community Services Manager discussed with the Committee the City Hall/Library Accessibility Improvements project schedule, and noted that the Arts and Culture Subcommittee would be meeting in late November to consider a movie for showing in January 2013.
