IV. COMMITTEE BUSINESS

A. Committee Charge and Responsibilities

City Manager Leslie Keane distributed and reviewed a list of program areas that are within the purview of the Public Safety Committee. A copy of the Circulation Element from the City's General Plan was also distributed for review by Committee members before the next meeting.

B. Review of Committee Procedures, Open Meeting Act and Conflict of Interest Regulations

City Manager Leslie Keane distributed and reviewed three documents: Committee Procedures, Brown Act – Open Meetings Law, and Conflict of Interest regulations. The City's ethics policy will be distributed with the agenda packet for the Committee's next meeting.

C. Modifications to City's Animal Regulations

The Committee discussed the Animal Services Committee's proposed changes to Laguna Woods animal regulations.

1. Animal Limit in Residential Units

The Committee voted, without objection, to recommend that the City Council approve the proposed limit of three animals per residential unit, with a modification that no more than two dogs be allowed.

2. Mandatory Spay-Neutering of Cats and Dogs

The Committee voted, without objection, to recommend that the City Council approve the proposed mandatory spay-neutering requirement for dogs and cats residing in Laguna Woods. The Committee further recommended that the City Council establish a financial assistance program for low-income residents prior to January 1, 2010.

Types of Traffic Control Devices

- Traffic and pedestrian signals
- Stop signs
- Crosswalks
- Street medians – solid and painted
- Speed limit signs – speed surveys are required every five years if traffic enforcement includes the use of radar
- Directional/restriction signs, such a “no right turn on red”, “no parking” and “yield”

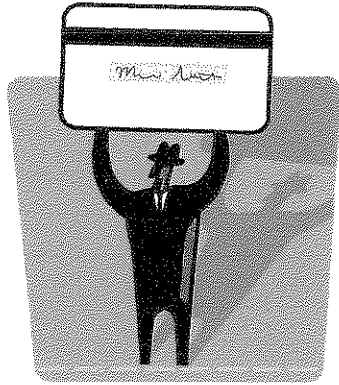
